### **COVID-19 TESTING**

Residents in Health Care and Personal Care and Fairmount team members tested for COVID-19 on January 21 and 22. The results were as follows:

- 272 negative results
- 1 positive result

The positive result came from an asymptomatic Health Care resident who was subsequently admitted into the Dogwood dedicated COVID treatment center.

Results from testing of Health Care and Personal Care residents and Fairmount team members from the week of January 25 yielded:

- 207 negative results
- 2 positive results
- 3 results pending

The positive results came from one direct caregiver and one non-direct caregiver. The team members will quarantine at home before returning to Fairmount.

Three Residential Living residents tested positive this week and are quarantining in their residences.

# HEALTH CARE, PERSONAL CARE & FAIRMOUNT STAFF COVID-19 VACCINATIONS

On January 22 and 23, CVS Pharmacy administered COVID-19 vaccinations for residents in Health Care and Personal Care and for Fairmount team members. For some, it was their second dose and, for others it was their first. CVS staff will administer second doses of the COVID-19 vaccinations to residents in Health Care, Personal Care, as well as Fairmount team members on February 12 and 13.

It is important to remember to continue following the COVID-19 safety precautions of wearing masks, practicing physical distancing and washing hands regularly. These protocols remain in place even if you have been vaccinated.

### RESIDENTIAL LIVING COVID-19 VACCINATIONS

Over 70% of our Residential Living residents have signed up to receive the COVID vaccination being administered by Stauffer's Pharmacy. Stauffer's has placed an order from the state for the vaccines and will schedule a clinic for administering the vaccine when the state informs them of the delivery date.

<u>FARM CREST PERSONAL CARE</u>: Visitation will resume on January 31 and will be available on Sundays, Wednesdays and Fridays. The visits will take place in a newly-created visitation room in the Farm Crest Gathering Room. To reserve a visit, please call 717-354-1823.

<u>WHEAT RIDGE PERSONAL CARE</u>: Visitation will resume on January 31 and will be available on Sundays, Tuesdays, and Thursdays. The visits will take place in the Wheat Ridge Personal Care sunroom with a clear divider in between the resident and the visitor. ## **DOGWOOD HALLWAY UPDATE**

There were three admissions into the Dogwood dedicated COVID treatment center this week and four discharges. To date, we have cared for 119 individuals in Dogwood since early April.
