# You Never Retire From a Life of Service

Janet and Irvin Wenger carefully planned their retirement for the beginning of 2020. After diligent research, a lot of number-crunching, and discovering the availability of an apartment with the layout and view they wanted, they chose Fairmount to be their new home. They loved that several friends live at Fairmount, it is close to where they grew up, and one of their three children lives nearby.

As per their plan, the Wengers sold their house in Guatemala where they had lived since 1980 and gave up their teaching and leadership positions-Janet taught music and Irvin taught ministry courses at the Central American Theological Seminary; they were both heads of their departments. Irvin agreed to continue serving as treasurer for FAM, a Latin American mission agency. They looked forward to life without the burdens of home maintenance and the demands of full-time work. Their plans were to relax and reconnect with friends and family. They packed their belongings, booked flights, and stepped into retirement at Fairmount.

Then their lives took an unexpected turn. As the pandemic forced school programs to move online, Janet's successor in Guatemala found it difficult to take on all of the classes Janet had been

teaching. Janet was called back to the mission field, teaching one of the classes via a modified Zoom platform. She gladly agreed, knowing she was able to contribute to the lives of students thousands of miles from their new Fairmount home.

"I had to create lesson plans from scratch! But we love that we can continue to give back and invest in the lives of others."

In addition to his role as treasurer for FAM, Irvin also agreed to teach a three-month, crosscultural online ministry course at the Seminary, and to serve as a thesis advisor. They both agree, "Our lives are happy and fulfilled as we continue with our mission, just not exactly as planned.

## It Was a Giddy Experience

The President's Perspective

Residential Living residents on our Fairmount campus outnumber those in all of our other living areas. However, this was not always the case. Fairmount first opened its doors in 1968, but it took another 12 years before the first person moved into what we now refer to as Residential Living.

Board minutes from 1967 reveal a decision by our founders to build cottages for "independent living" along Farm Crest Drive. However, demand for health care was so strong that expansion in that area took priority, postponing cottage development for a decade. Construction on the first two cottages began in late 1979, and the first residents moved to Fairmount six months later.

The next phase of Residential Living was again delayed until 1992, this time by the need to build a required wastewater treatment plant. In April 2000, Fairmount's first apartment residents moved into the renovated Farm Crest building, followed just five years later by occupancy of the new, four-story Crest View Apartment building. In the subsequent 15 years, more cottages and apartments were added, bringing the total Fairmount Residential Living accommodations to 103 apartments and 52 cottages. Over the years they have been home to more than 500 residents.

Earl Osborn, the first resident to reserve a Nolt Drive cottage in 1997, has resided in a Residential Living unit longer than any other resident. "It was a giddy experience

A first-floor hallway named Dogwood was chosen, partially because it had its own separate entrance. Negative pressure equipment was installed to move air outside rather than circulating inside.

Staff who offered to work in this area went through special training and were issued personal protection equipment (PPE) to work safely in this unit.

Not only was Fairmount ready to serve its own residents who tested positive with COVID, it was equipped to take residents with COVID-19 from hospitals, other retirement homes, and the broader community who needed a place to recover. While other nursing homes were turning these residents away, Fairmount was welcoming them.

By the end of 2020, the Dogwood COVID Unit had reached the milestone of serving its 100th resident; by the end of February, 122 individuals had been cared for in Dogwood.
