### **Celebrating 55 Years**

February 19, 2023, is a special day for Fairmount as it marks another important milestone in our history —55 years of serving our community. Jim Oswald, Fairmount's Chief Executive Officer (CEO) from 1987 to 2008, was a part of two decades of that history. He recently commented on how the mission and values shaped these  $5\frac{1}{2}$  decades of Fairmount's service.

Jim has great admiration for Katie Kurtz, the woman whose vision and spirit were the driving force behind Fairmount's beginnings. "She was not concerned about herself," explains Jim. "She wanted to provide care for whomever needed help, regardless of religious affiliation or financial situation."

Jim was at the helm of the Fairmount community during a period of significant growth. His tenure saw "Fairmount Rest Home" grow from a small health care facility into a 48 acre campus flanking two sides of Cats Back Road with expanded living options that included Health Care, Personal Care, 39 cottages, and a four-story apartment building. His careful attention to detail guided the construction of the initial Wheat Ridge campus as well as the 49-unit Crest View Apartment building.

Since Jim's retirement, Fairmount has continued to both renovate and grow. A state-of-the-art Rehab Center, additional cottages, and the four-story Wheat Ridge Apartment building were major projects completed in the past 15 years under the leadership of President/CEO Jerry D. Lile.

But Jim Oswald's relationship with Fairmount wasn't finished. When health challenges made it difficult for him to maintain their home, Jim and his wife Phyllis decided it was time to move. "If I couldn't keep it up myself, I didn't want to be there," he says. Where did they choose to go? Fairmount!

### Deciding Factors of Quality Care and Community

Jim shares his reasons for choosing to become a Fairmount resident: "The high standards of health care, evidenced by consistently outstanding Department of Health ratings over the years, was the deciding factor for me. The availability of excellent nursing care when we would need it is what mattered most to us.

"The core values and mission of the organization, and the faith and values of the people in this community were another major draw for us," Jim continues. "Katie's initial vision withstood the test of time. The values Fairmount was founded on continue strong today, and they aligned with our values and ideals. People at Fairmount may differ in some of their perspectives, ways of life and thinking, but Jesus and caring for each other are at the core of this community, and that's what is crucial."


Now in my 16th year at Fairmount,
